THE FOLLOWING IS MADE A CONDITION OF THIS RENTAL

The undersigned (hereinafter referred to as "Renter") hereby assumes all responsibility for any and all damages or loss to said equipment and agrees to pay the full cost of all repairs if it is in any way rendered out of service, whether this be occurred through accident, neglect or misuse. In case of loss or destruction of equipment or loss of possession thereof or inability to return same to Sandor Rental Equipment the Renter agrees to pay Sandor Rental Equipment the complete and full value of equipment in cash.

The Renter agrees to compensate Sandor Rental Equipment at the stated rental rates for each day or week consumed while equipment is in the process of recovery or repair.

Renter agrees to have bolts examined in hitch, safety chain and all connections on said rented equipment to motor vehicle and to have received it in a sound condition.

The Renter hereby absolves Sandor Rental Equipment and its owner of any responsibility or obligation in the event of accident, damages or causes to be examined, and the Renter costs, claims, court or attorney's fees or liability resulting from the use of ordered equipment will be unconditionally paid by any legal costs against whom the claimant or litigants institute action.

The Renter agrees that all charges for rental will be paid in advance or immediately upon return of *above* described equipment and that all collection fees, attorney fees, court costs or any other expense involved in the collection of rental charges will be borne by the Renter.

The Renter further agrees that Sandor Rental Equipment may terminate this rental agreement at any time and demand return of *above* rented equipment and payment in full on all rentals owing in which case the Renter agrees to return said equipment and pay *above* rental in full.

Rental hours is anytime from 8:00 a.m. to 5:00 p.m., 1:00 p.m. to 8:00 a.m., 5:00 p.m. to 12:00 p.m. and the Renter is therefore responsible for any additional rental beyond time specified *above*. The *above* rental rate will be charged from the time equipment leaves our premises until it is returned to same.

Renter will be paying all cleaning charges on return until equipment returned unclean.
